IMPORTANT NOTICE:

Equine Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement

By signing this agreement, you are giving up certain legal rights, including the right to recover damages in case of injury, death, or property damage, arising out of your riding or use of the owner's horse, use of the facility, and/or participation in equine activities at Altadena Stables, LLC located at 3064 Ridgeview Drive, Altadena, California, 91001.

Read this agreement carefully before signing it. Your signature indicates your understanding and agreement to its terms.

By signing this form, I hereby acknowledge on behalf of myself and/or my child, that I have familiarized myself with the activities that I will be allowed to participate in, and that I do hereby acknowledge and agree that I will participate in these activities without restriction or limitation. I recognize the inherent risks involved in riding and working with horses, including but not limited to:

- Bites, kicks, abrasions or contusions from horses.
- Being thrown or bucked off by horses.
- Scratches or other injury from stalls or enclosures.
- Scratches or other injury from grooming tools and other equine equipment and tack.
- Allergic reactions to animals, hay, or other allergens.
- Tripping in holes or on materials or equipment.
- Slipping, falling, or otherwise being injured in the barn, in stalls, or on the grounds, which can be slippery, muddy, wet, or contain and/or present other hazards.

I hereby specifically forever release Altadena Stables, LLC and its principals and agents from any liability for injury arising out of the inherent risks from riding, working or participating in a stable environment and/or with horses, as well as from the negligence of Altadena Stables, LLC, its principals and agents.
